Dark Bay or Brown Filly, (Mar), by Street Cry (IRE) - Perfect Story by Tale of the Cat. Trainer Asmussen M. Steven. Bred by John C. Oxley(KY).

STREET STORY rode the rail on the turn, got put to encouragement entering the stretch, gained ground rapidly on the front runners, altered course to be outside them with slightly under a furlong remaining, continued onward, moved past the runner up in the final seventy yards and edged away. MISS BEHAVIOUR contently stalked the pacesetter from slightly off the rail, tipped into the three path after going half way around the turn, chopped away at the advantage during the remainder of the way to the quarter pole, spun into the stretch latched on to RED VELVET, was set down, won the fight through the furlong grounds to emerge as the new leader by the eighth pole, albeit by a slim margin, showed resistance before being collaring herself by the eventual winner in the final stages. MILAM departed the backstretch placed along the inside route, swung three wide into the stretch, rallied willingly enough to be along for the show. RED VELVET urged after the start, shook free of the others, carved out the pace placed in the two path, got put to the test coming to the quarter pole by the second place finisher, yielded deep into the furlong grounds, weakened steadily thereafter. WEST COAST CHICK settled into midpack after the start, came six wide into upper stretch, lacked the needed response. ISABELLE rank on the bit while down along the rail approaching the end of the stretch, commenced the run around the bend from the three path, failed to make her presence felt. FAT KAT out a couple of steps at the start, chased from off the rail, gave way.
