VYJACK away in good order, chased from afar at a considerable distance from off the inside proceeding down the backstretch, departed it being three wide but quickly worked out a tuck into the two path, picked up interest when asked to during the later stages of run around the bend, swung three wide into the stretch and took off in earnest after the leader, came out after some left handed stick work shortly afterwards, continued onward, catching up with a furlong to go, grabbed the advantage for good near the sixteenth marker and edged away, kept to a hand drive. SENSATIONAL SLAM was taken hold after being pinched at the start, gave chase from the two path on the turn, fanned towards the four path spinning into the lane, shied out a bit more right afterwards, reacting to the wayward winner at this juncture, continued onward in a willing manner, but had to settle for being second best. ROYAL CURRIER shook free of the others after the start and was sent over towards the inside, showed the way, well rated on an open lead, got released from a relaxed grip on the reins after reaching upper stretch, felt the winner's presence near the end of the furlong grounds, held out well before relinquishing with a sixteenth remaining, then weakened. NORTH OCEAN saved ground to the quarter pole, arrived at that station having already been asked for run, proved no match. BALANCE OF POWER saved ground to no avail.
