Gray or Roan Filly, (Feb), by Alphabet Soup - Rehocracy by Adhocracy. Trainer Mitchell R. Mike. Bred by Centaur Farms, Inc.(FL).

EGG DROP went up outside a rival to duel for the lead then stalked a bit off the rail, re-bid alongside that one on the second turn, took the lead into the stretch, inched away in midstretch, drifted out then in from the whip in the final furlong and held on gamely. APPEALING (IRE) angled inward in the chute, chased a bit off the rail then inside on the second turn, came out into the stretch, bid between horses past midstretch then toward the inside, reached even terms with the winner, drifted out some from the whip in deep stretch and just missed. MY GI GI bumped at the start, saved ground chasing the pace, came out into the stretch, split rivals in midstretch, rallied, steadied between the top pair in deep stretch and edged a rival for third. HALO DOLLY angled in and stalked outside then off the rail, came three deep into the stretch and could not quite summon the necessary late kick. CUSTOMER BASE pulled between horses then chased off the rail, went up three deep leaving the backstretch and on the second turn, came four wide into the stretch and also lacked the needed late response. CLOSING RANGE broke in and bumped a rival at the start, settled outside a foe or off the rail, came out four wide into the stretch and could not offer the necessary response. QUIET OASIS (IRE) bumped between foes at the start, stalked a bit off the rail then between rivals on the second turn, came out some in the stretch and weakened in the final furlong. A JEALOUS WOMAN had speed outside foes then angled in, duelled inside then inched away, set the pace along the rail, fought back on the second turn and into the stretch and also weakened in the final furlong. ROYAL EMPRESS (IRE) pulled her way along outside then angled in, chased a bit off the rail then between horses on the second turn, dropped back in the stretch and also weakened. The stewards conducted an inquiry into the late stretch run of the top three finishers but made no change when they ruled the trouble to MY GI GI occurred too late to alter the original order of finish.
